The privacy practices of this statement apply to our services available under the domain and subdomains of www.etechsurplus.com (the "Site"). By sending eTech Surplus your email address or other personal information, you agree to be bound by the terms and conditions of this Privacy Policy.

This Privacy Policy describes the information, as part of the normal operation of our services, we collect from you and what may happen to that information. We have prepared a detailed policy because we believe you should know as much as possible about the practices of eTech Surplus so that you can make informed decisions. Subject to the requirements of applicable law, we strive to provide a consistent set of privacy practices.

By accepting the Privacy Policy, you expressly consent to our use and disclosure of your personal information in accordance with this Privacy Policy. This Privacy Policy is effective upon acceptance.

A Note About Children

Children (persons under the age of 18) are not eligible to purchase any products from eTech Surplus and are expressly forbidden from sending us their email and/or any personal information. If you are under the age of 18, you may only browse this Site in conjunction with and under the supervision of your parents or guardians.

Information We Collect

Our primary purpose in collecting personal information is to provide eTech Surplus a way to contact you via email and/or standard mail for the purpose of marketing our products. We only collect personal information about you that we consider necessary for achieving this purpose.

You can browse the Site without telling us who you are or revealing any personal information about yourself. Once you give us your personal information, you are not anonymous to us. If you choose to provide us with your personal information, we will require you to provide contact and identity information and possibly other personal information if and when required. If you purchase from us or send us personal correspondence, such as emails or letters, we may collect such information into a file specific to you, but we will not use this information for our marketing purposes without your consent.

Our Use of Your Information

If you agree to be on our mailing list, we will contact you periodically with a list of products or services we have for sale. As stated above, if you do not expressly agree to be on our mailing list, we will only use your information as necessary to complete a transaction or answer a question you may have. Our Disclosure of Your Information

As a matter of policy, we do not sell or rent any of your personal information to third parties for any reason. However, the following describes some of the ways that your personal information may be disclosed in the normal scope of business to provide our services.

Legal Requests. eTech Surplus cooperates with law enforcement inquiries, as well as other third parties to enforce laws, such as: intellectual property rights, fraud and other rights, to help protect you and eTech Surplus. Therefore, in response to a verified request by law enforcement or other government officials relating to a criminal investigation or alleged illegal activity, we can (and you authorize us to) disclose all personal information eTech Surplus has about you, without a subpoena. Without limiting the above, in an effort to respect your privacy, we will not otherwise disclose your personal information to law enforcement or other government officials without a subpoena, court order or substantially similar legal procedure, except when we believe in good faith that the disclosure of information is necessary to: prevent imminent physical harm or financial loss; or report suspected illegal activity. Due to the existing regulatory environment, we cannot ensure that all of your private communications and other personal information will never be disclosed in ways not otherwise described in this Privacy Policy. By way of example (without limiting the foregoing), we may be forced to disclose personal information to the government or third parties under certain circumstances and third parties may unlawfully intercept or access transmissions or private communications. Therefore, although we use every precaution to protect your privacy, we do not promise, and you should not expect, that your personal information or private communications will always remain private.
